

Q.1 a) Charter Party to load 70500 mt 2% MOL00 Grain from New Orleans @14000 per WWD consecutive hours, SHEX EIU. Time not to count between 1200 hrs on Saturday to 0600 hrs on Monday and from 1200 hrs of day before holiday to 0600 hrs of first working day after a holiday. Lay time starts 12 hrs after NORT. Vessel arrived on 25/9 Thursday, NORT and Master's declaration of 70000 mt of cargo at 0900 hrs on same day and accepted. Loading commenced 1300 hrs 25/9 and completed at 0200 hrs on Tuesday 7/10. Rain 1600 to 1800 hrs on 25/9 and between 0900 to 1900hrs on 2/10 and 0600 to 1200 hrs on 7/10, 1/10 and 3/10 are local holidays. Demurrage 5000 5/day and prorate. Despatch on all working time saved to be half of demurrage. Prepare a lay time statement and calculate amount charter should pay to the vessel, if freight rate was 30/-\$/ts and 2% brokerage to be allowed. 50% of freight is paid in advance.





Thursday 29th September was a public holiday. Demurrage to be paid at USD300 per day and pro rata for part of a day; despatch at USD 180 per day and pro rata. State when the laydays expire and calculate the amount of demurrage or despatch to be paid.





Loading finished at 1600 hrs on the 8th May, N.O.R. was accepted at the discharge port at 1500 hrs on the 18th May and discharging was completed at 1830 on the 22nd of May. The demurrage rate is 750 usd per day or pro-rata. Despatch money is not payable. Freight is due at usd 3.90 per tonne less 4% insurance. Calculate the amount due to the ship on completion of discharge.






